## POA EXHIBITOR OFFICE FEES

National POA Fee . . . . . \$28/Pony [\$7 per judge]

Wisconsin State POA Fee . . . \$16/Pony [\$4 per judge]

## OPEN EXHIBITOR OFFICE FEES

Show Office Fee . . . . . \$10/Horse
